Parents are required to follow the recommendations outlined in a Behavior Plan to reduce inappropriate behavior. If inappropriate behavior persists and causes harm to other students or staff, parents may be asked to remove the child from the school environment until the school team deems it appropriate for the child to return.

There is a policy of absolutely no physical punishment by the all employees and therapy staff.
